15 stating amounts of the appropriations; stating purposes and
16 restrictions; authorizing and requiring certain expenditures;
17 authorizing and requiring certain transfers; requiring certain
18 deposit; and providing an effective date.

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. There is hereby appropriated to the State Board
21 of Education from any monies not otherwise appropriated from the
22 Education Reform Revolving Fund created in Section 41.29b of Title
23 62 of the Oklahoma Statutes, the sum of Five Hundred Ninety-nine
24 Million Six Hundred Five Thousand One Hundred Eighty-one Dollars
25 (\$599,605,181.00) or so much thereof as may be necessary for the
26 financial support of public schools.

27 SECTION 2. The State Board of Education is hereby

1 authorized to expend during the fiscal year ending June 30, 2011,
2 from the Common Education Technology Revolving Fund of the State

3 Treasury, the sum of Forty-seven Million Three Hundred Seventy-two
4 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) or so
5 much thereof as may be necessary for the financial support of
6 public schools.

7 SECTION 3. There is hereby appropriated to the State Board
8 of Education from any monies not otherwise appropriated from the
9 Mineral Leasing Fund of the State Treasury for the fiscal year
10 ending June 30, 2011, the sum of Four Million Eighty-five Thousand
11 Dollars (\$4,085,000.00) or so much thereof as may be necessary for
12 the financial support of public schools.

13 SECTION 4. There is hereby appropriated to the State Board
14 of Education from any monies not otherwise appropriated from the
15 Mineral Leasing Fund of the State Treasury for the fiscal year
16 ending June 30, 2009, the sum of One Million Six Hundred Fifty-
17 five Thousand Eight Hundred Seventy-six Dollars (\$1,655,876.00) or
18 so much thereof as may be necessary for the financial support of
19 public schools.

20 SECTION 5. There is hereby appropriated to the State Board
21 of Education from any monies not otherwise appropriated from the
22 Oklahoma Education Lottery Trust Fund of the State Treasury for
23 the fiscal year ending June 30, 2011, the sum of Twenty-seven
24 Million Six Hundred Ninety-eight Thousand Seven Hundred Thirty
25 Dollars (\$27,698,730.00) or so much thereof as may be necessary
26 for the financial support of public schools.

27 SECTION 6. The State Board of Education is hereby

1 authorized to expend from the Education Stabilization component of
2 the American Recovery and Reinvestment Act Fund, the sum of One

3 Hundred Thirty-nine Million Five Hundred Twenty-one Thousand Six
4 Hundred Thirty-five Dollars (\$139,521,635.00) or so much thereof
5 as may be necessary to perform the duties imposed upon the State
6 Board of Education by law.

7 SECTION 7. There is hereby appropriated to the State Board
8 of Education from any monies not otherwise appropriated from the
9 General Revenue Fund of the State Treasury for the fiscal year
10 ending June 30, 2011, the sum of Four Hundred Nineteen Million
11 Seven Hundred Eighty-nine Thousand Four Dollars (\$419,789,004.00)
12 or so much thereof as may be necessary for the support of public
13 schools activities.

14 SECTION 8. There is hereby appropriated to the State Board
15 of Education from any monies not otherwise appropriated from the
16 General Revenue Fund of the State Treasury for the fiscal year
17 ending June 30, 2011, the sum of Twenty-two Million Three Hundred
18 Forty-two Thousand Six Hundred Ninety-two Dollars (\$22,342,692.00)
19 or so much thereof as may be necessary for administrative and
20 support functions of the State Department of Education.

21 SECTION 9. There is hereby appropriated to the State Board
22 of Education from any monies not otherwise appropriated from the
23 Oklahoma Education Lottery Trust Fund of the State Treasury for
24 the fiscal year ending June 30, 2011, the sum of Three Million
25 Seventy-seven Thousand Six Hundred Thirty-seven Dollars
26 (\$3,077,637.00) or so much thereof as may be necessary for
27 transfer to the School Consolidation Assistance Fund.

1 SECTION 10. There is hereby appropriated to the State Board
2 of Education from any monies not otherwise appropriated from the
3 Oklahoma Education Lottery Trust Fund of the State Treasury for

4 the fiscal year ending June 30, 2011, the sum of Three Million
5 Seventy-seven Thousand Six Hundred Thirty-seven Dollars
6 (\$3,077,637.00) or so much thereof as may be necessary for
7 transfer to the Teachers' Retirement System Dedicated Revenue
8 Revolving Fund.

9 SECTION 11. There is hereby appropriated to the
10 Commissioners of the Land Office from any monies not otherwise
11 appropriated from the Commissioners of the Land Office Fund of the
12 State Treasury for the fiscal year ending June 30, 2011, the sum
13 of Seven Million One Hundred Nine Thousand Dollars (\$7,109,000.00)
14 or so much thereof as may be necessary to perform the duties
15 imposed upon the Commissioners of the Land Office by law.

16 SECTION 12. There is hereby appropriated to the Board of
17 Trustees of the Oklahoma School of Science and Mathematics from
18 any monies not otherwise appropriated from the General Revenue
19 Fund of the State Treasury for the fiscal year ending June 30,
20 2011, the sum of Six Million Five Hundred Forty Thousand Eighty
21 Dollars (\$6,540,080.00) or so much thereof as may be necessary to
22 perform the duties imposed upon the Board of Trustees of the
23 Oklahoma School of Science and Mathematics by law.

24 SECTION 13. There is hereby appropriated to the Oklahoma
25 Commission for Teacher Preparation from any monies not otherwise
26 appropriated from the General Revenue Fund of the State Treasury
27 for the fiscal year ending June 30, 2011, the sum of One Million

1 Six Hundred Forty-one Thousand Fifty-three Dollars (\$1,641,053.00)
2 or so much thereof as may be necessary to perform the duties
3 imposed upon the Oklahoma Commission for Teacher Preparation by

4 law.

5 SECTION 14. There is hereby appropriated to the State Board
6 of Career and Technology Education from any monies not otherwise
7 appropriated from the General Revenue Fund of the State Treasury
8 for the fiscal year ending June 30, 2011, the sum of One Hundred
9 Thirty-eight Million Five Hundred Ninety-one Thousand Nine Hundred
10 Two Dollars (\$138,591,902.00) or so much thereof as may be
11 necessary to perform the duties imposed upon the State Board of
12 Career and Technology Education by law.

13 SECTION 15. There is hereby appropriated to the State Board
14 of Career and Technology Education from any monies not otherwise
15 appropriated from the Oklahoma Education Lottery Trust Fund of the
16 State Treasury for the fiscal year ending June 30, 2011, the sum
17 of Three Million Three Hundred Eighty-five Thousand Four Hundred
18 Dollars (\$3,385,400.00) pursuant to paragraph 2 of subsection C of
19 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
20 the State Board of Career and Technology Education for the
21 education and general operating budgets of the institutions and
22 for other programs, construction, renovations or repairs
23 administered by the State Board of Career and Technology
24 Education.

25 SECTION 16. There is hereby appropriated to the Oklahoma
26 State Regents for Higher Education from any monies not otherwise
27 appropriated from the General Revenue Fund of the State Treasury

1 for the fiscal year ending June 30, 2011, the sum of Seven Hundred
2 Forty-nine Million Six Hundred Thousand Seventy-eight Dollars
3 (\$749,600,078.00) or so much thereof as may be necessary for
4 allocation by the Oklahoma State Regents for Higher Education

5 pursuant to the provisions of Article XIII-A of the Oklahoma
6 Constitution for the education and general operating budgets of
7 the institutions and for other programs, construction, renovations
8 or repairs administered by the Oklahoma State Regents for Higher
9 Education. Of those funds appropriated, the sum of Four Million
10 Sixty-five Thousand Eight Hundred Fifty-eight Dollars
11 (\$4,065,858.00) shall be transferred to the Oklahoma Tuition
12 Equalization Grant Trust Fund to implement the provisions of the
13 Oklahoma Tuition Equalization Grant Act.

14 SECTION 17. The Oklahoma State Regents for Higher Education
15 are hereby authorized to expend during the fiscal year ending June
16 30, 2011, the sum of Forty-eight Million Seven Hundred Sixty-seven
17 Thousand Seven Hundred Five Dollars (\$48,767,705.00) from the
18 Higher Education Capital Revolving Fund of the State Treasury for
19 allocation by the Oklahoma State Regents for Higher Education
20 pursuant to the provisions of Article XIII-A of the Oklahoma
21 Constitution for the education and general operating budgets of
22 the institutions and for other programs, construction, renovations
23 or repairs administered by the Oklahoma State Regents for Higher
24 Education.

25 SECTION 18. The Oklahoma State Regents for Higher Education
26 are hereby authorized to expend during the fiscal year ending June
27 30, 2011, the sum of Forty-eight Million Seven Hundred Sixty-seven

1 Thousand Seven Hundred Five Dollars (\$48,767,705.00) from the
2 Oklahoma Student Aid Revolving Fund of the State Treasury for
3 allocation by the Oklahoma State Regents for Higher Education
4 pursuant to the provisions of Article XIII-A of the Oklahoma

5 Constitution for the education and general operating budgets of
6 the institutions and for other programs, construction, renovations
7 or repairs administered by the Oklahoma State Regents for Higher
8 Education.

9 SECTION 19. There is hereby appropriated to the Oklahoma
10 State Regents for Higher Education from any monies not otherwise
11 appropriated from the Special Cash Fund of the State Treasury the
12 sum of Sixty-five Million Dollars (\$65,000,000.00) for allocation
13 by the Oklahoma State Regents for Higher Education pursuant to the
14 provisions of Article XIII-A of the Oklahoma Constitution for the
15 education and general operating budgets of the institutions and
16 for other programs, construction, renovations or repairs
17 administered by the Oklahoma State Regents for Higher Education.

18 SECTION 20. There is hereby appropriated to the Oklahoma
19 State Regents for Higher Education from any monies not otherwise
20 appropriated from the proceeds of the sale of bonds deposited in
21 the Oklahoma Building Bonds of 1992 Fund A in the State Treasury,
22 the sum of Four Hundred Thirty-two Dollars (\$432.00) or so much
23 thereof as may be necessary for allocation by the Oklahoma State
24 Regents for Higher Education pursuant to the provisions of Article
25 XIII-A of the Oklahoma Constitution for the education and general
26 operating budgets of the institutions and for other programs,
27 construction, renovations or repairs administered by the Oklahoma

1 State Regents for Higher Education.

2 SECTION 21. There is hereby appropriated to the Oklahoma
3 State Regents for Higher Education from any monies not otherwise
4 appropriated from the proceeds of the sale of bonds deposited in
5 the Oklahoma Building Bonds of 1992 Fund B in the State Treasury,

6 the sum of Two Hundred Twenty-six Dollars (\$226.00) or so much
7 thereof as may be necessary for allocation by the Oklahoma State
8 Regents for Higher Education pursuant to the provisions of Article
9 XIII-A of the Oklahoma Constitution for the education and general
10 operating budgets of the institutions and for other programs,
11 construction, renovations or repairs administered by the Oklahoma
12 State Regents for Higher Education.

13 SECTION 22. There is hereby appropriated to the Oklahoma
14 State Regents for Higher Education from any monies not otherwise
15 appropriated from the General Revenue Fund of the State Treasury
16 for the fiscal year ending June 30, 2011, the sum of One Million
17 Three Hundred Ten Thousand One Hundred Sixty-three Dollars
18 (\$1,310,163.00) or so much thereof as may be necessary for
19 expenditures for concurrent enrollment pursuant to Section 628.13
20 of Title 70 of the Oklahoma Statutes.

21 SECTION 23. There is hereby appropriated to the Oklahoma
22 State Regents for Higher Education from any monies not otherwise
23 appropriated from the Oklahoma Education Lottery Trust Fund of the
24 State Treasury for the fiscal year ending June 30, 2011, the sum
25 of Twenty-four Million Three Hundred Thirteen Thousand Three
26 Hundred Thirty Dollars (\$24,313,330.00) pursuant to paragraph 2 of
27 subsection C of Section 713 of Title 3A of the Oklahoma Statutes

1 for allocation by the Oklahoma State Regents for Higher Education
2 pursuant to the provisions of Article XIII-A of the Oklahoma
3 Constitution for construction, renovations or repairs administered
4 by the Oklahoma State Regents for Higher Education or for any
5 other purpose authorized by paragraph 2 of subsection C of Section

6 713 of Title 3A of the Oklahoma Statutes.

7 SECTION 24. There is hereby appropriated to the Oklahoma
8 State Regents for Higher Education from any monies not otherwise
9 appropriated from the General Revenue Fund of the State Treasury
10 for the fiscal year ending June 30, 2011, the sum of Five Million
11 Two Hundred Four Thousand Four Hundred Five Dollars
12 (\$5,204,405.00) or so much thereof as may be necessary for the
13 general operating budget of the Administrative Offices of the
14 Oklahoma State Regents for Higher Education.

15 SECTION 25. There is hereby appropriated to the Oklahoma
16 State Regents for Higher Education from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury
18 for the fiscal year ending June 30, 2011, the sum of Seven Hundred
19 One Thousand Nine Hundred Eighty-six Dollars (\$701,986.00) or so
20 much thereof as may be necessary for the Office of Accountability
21 to perform the duties imposed upon the Office of Accountability by
22 law.

23 SECTION 26. The Oklahoma State Regents for Higher Education
24 are hereby authorized to expend from the Education Stabilization
25 component of the American Recovery and Reinvestment Act Fund the
26 sum of Fifty-nine Million Seven Hundred Ninety-four Thousand Nine
27 Hundred Eighty-six Dollars (\$59,794,986.00) or so much thereof as

1 may be necessary for the allocation by the Oklahoma State Regents
2 for Higher Education pursuant to the provisions of Article XIII-A
3 of the Oklahoma Constitution for the education and general
4 operation budgets of the institutions and for other programs,
5 construction, renovations or repairs administered by the Oklahoma
6 State Regents for Higher Education.

7 SECTION 27. There is hereby appropriated to the Physician
8 Manpower Training Commission from any monies not otherwise
9 appropriated from the General Revenue Fund of the State Treasury
10 for the fiscal year ending June 30, 2011, the sum of Three Million
11 Three Hundred Forty Thousand Two Hundred Eighty-seven Dollars
12 (\$3,340,287.00) or so much thereof as may be necessary to perform
13 the duties imposed upon the Physician Manpower Training Commission
14 by law.

15 SECTION 28. There is hereby appropriated to the Physician
16 Manpower Training Commission from any monies not otherwise
17 appropriated from the Special Cash Fund of the State Treasury, the
18 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
19 thereof as may be necessary to perform the duties imposed upon the
20 Physician Manpower Training Commission by law.

21 SECTION 29. The Physician Manpower Training Commission is
22 hereby authorized to expend from the American Recovery and
23 Reinvestment Act Fund, the sum of One Million Seventy-two Thousand
24 Eighty Dollars (\$1,072,080.00) or so much thereof as may be
25 necessary to perform the duties imposed upon the Physician
26 Manpower Training Commission by law.

27 SECTION 30. The Oklahoma Board of Private Vocational

1 Schools is hereby authorized to expend during the fiscal year
2 ending June 30, 2011, from the Oklahoma Board of Private
3 Vocational Schools Revolving Fund of the State Treasury, the sum
4 of One Hundred Sixty-seven Thousand One Hundred Ninety-four
5 Dollars (\$167,194.00) or so much thereof as may be necessary to
6 perform the duties imposed upon the Board of Private Vocational

7 Schools by law.

8 SECTION 31. There is hereby appropriated to the Oklahoma
9 Arts Council from any monies not otherwise appropriated from the
10 General Revenue Fund of the State Treasury for the fiscal year
11 ending June 30, 2011, the sum of Four Million Four Hundred Six
12 Thousand Six Hundred Eighty-nine Dollars (\$4,406,689.00) or so
13 much thereof as may be necessary to perform the duties imposed
14 upon the Oklahoma Arts Council by law.

15 SECTION 32. There is hereby appropriated to the Oklahoma
16 Educational Television Authority from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury
18 for the fiscal year ending June 30, 2011, the sum of Four Million
19 Two Hundred Thousand Three Hundred Sixty Dollars (\$4,200,360.00)
20 or so much thereof as may be necessary to perform the duties
21 imposed upon the Oklahoma Educational Television Authority by law.

22 SECTION 33. There is hereby appropriated to the Oklahoma
23 Department of Libraries from any monies not otherwise appropriated
24 from the General Revenue Fund of the State Treasury for the fiscal
25 year ending June 30, 2011, the sum of Six Million Three Hundred
26 Forty-two Thousand Six Hundred Sixteen Dollars (\$6,342,616.00) or
27 so much thereof as may be necessary to perform the duties imposed

2 SECTION 34. There is hereby appropriated to the Oklahoma
3 Center for the Advancement of Science and Technology from any
4 monies not otherwise appropriated from the General Revenue Fund of
5 the State Treasury for the fiscal year ending June 30, 2011, the
6 sum of Nineteen Million One Hundred Fifty-two Thousand Ninety-six
7 Dollars (\$19,152,096.00) or so much thereof as may be necessary to

8 perform the duties imposed upon the Oklahoma Center for the
9 Advancement of Science and Technology by law.

10 SECTION 35. There is hereby appropriated to the Office of
11 the State Auditor and Inspector from any monies not otherwise
12 appropriated from the General Revenue Fund of the State Treasury
13 for the fiscal year ending June 30, 2011, the sum of Four Million
14 Eight Hundred Twenty-two Thousand Five Hundred Eighty-seven
15 Dollars (\$4,822,587.00) or so much thereof as may be necessary to
16 perform the duties imposed upon the Office of the State Auditor
17 and Inspector by law.

18 SECTION 36. There is hereby appropriated to the Office of
19 the State Auditor and Inspector from any monies not otherwise
20 appropriated from the General Revenue Fund of the State Treasury
21 for the fiscal year ending June 30, 2011, the sum of Three Hundred
22 Thirty Thousand Eighty-six Dollars (\$330,086.00) or so much
23 thereof as may be necessary to perform the duties imposed upon the
24 Commission on County Government Personnel Education and Training.
25 The appropriation made in this section shall be expended
26 exclusively for the purpose so stated and shall not be
27 transferable.

1 SECTION 37. There is hereby appropriated to the Office of
2 the State Bond Advisor from any monies not otherwise appropriated
3 from the General Revenue Fund of the State Treasury for the fiscal
4 year ending June 30, 2011, the sum of One Hundred Fifty-five
5 Thousand Five Hundred Fifty-six Dollars (\$155,556.00) or so much
6 thereof as may be necessary to perform the duties imposed upon the
7 Office of the State Bond Advisor by law.

8 SECTION 38. There is hereby appropriated to the Department
9 of Central Services from any monies not otherwise appropriated
10 from the General Revenue Fund of the State Treasury for the fiscal
11 year ending June 30, 2011, the sum of Thirteen Million Six Hundred
12 Fifty-seven Thousand Sixty-six Dollars (\$13,657,066.00) or so much
13 thereof as may be necessary to perform the duties imposed upon the
14 Department of Central Services by law.

15 SECTION 39. There is hereby appropriated to the Department
16 of Central Services from any monies not otherwise appropriated
17 from the General Revenue Fund of the State Treasury for the fiscal
18 year ending June 30, 2011, the sum of One Hundred Fifty-one
19 Thousand Five Hundred Eighteen Dollars (\$151,518.00) or so much
20 thereof as may be necessary to maintain the Hissom Memorial
21 Center.

22 SECTION 40. There is hereby appropriated to the Department
23 of Central Services from any monies not otherwise appropriated
24 from the Public Building Fund of the State Treasury for the fiscal
25 year ending June 30, 2009, the sum of Six Hundred Sixty Three
26 Thousand One Hundred Ninety-eight Dollars (\$663,198.00) to be
27 transferred to the Building and Facility Revolving Fund created in

1 Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose
2 of maintaining state buildings operated by the Department of
3 Central Services.

4 SECTION 41. There is hereby appropriated to the Department
5 of Central Services from any monies not otherwise appropriated
6 from the Public Building Fund of the State Treasury for the fiscal
7 year ending June 30, 2011, the sum of One Million Five Hundred One
8 Thousand Two Hundred Forty-nine Dollars (\$1,501,249.00) or so much

9 thereof as may be necessary to be transferred to the Building and
10 Facility Revolving Fund created in Section 63.1 of Title 74 of the
11 Oklahoma Statutes for the purpose of maintaining state buildings
12 operated by the Department of Central Services.

13 SECTION 42. There is hereby appropriated to the State
14 Election Board from any monies not otherwise appropriated from the
15 General Revenue Fund of the State Treasury for the fiscal year
16 ending June 30, 2011, the sum of Five Million Four Hundred Eighty-
17 eight Thousand Ninety-four Dollars (\$5,488,094.00) or so much
18 thereof as may be necessary to perform the duties imposed upon the
19 State Election Board by law.

20 SECTION 43. There is hereby appropriated to the State
21 Election Board from any monies not otherwise appropriated from the
22 Special Cash Fund of the State Treasury, the sum of Two Million
23 Five Hundred Fifty-nine Thousand One Hundred Thirty-one Dollars
24 (\$2,559,131.00) or so much thereof as may be necessary to perform
25 the duties imposed upon the State Election Board by law.

26 SECTION 44. There is hereby appropriated to the Oklahoma
27 Department of Emergency Management from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury
2 for the fiscal year ending June 30, 2011, the sum of Six Hundred
3 Ninety-two Thousand Seven Hundred Forty-four Dollars (\$692,744.00)
4 or so much thereof as may be necessary to perform the duties
5 imposed upon the Oklahoma Department of Emergency Management by
6 law.

7 SECTION 45. There is hereby appropriated to the Ethics
8 Commission from any monies not otherwise appropriated from the

9 General Revenue Fund of the State Treasury for the fiscal year
