

## Voter Registration Verification Form Instructions

Those seeking to run for school board are now required to file a voter registration verification form along with the declaration of candidacy. The form can be obtained through the Oklahoma State Election Board's online portal or at your county election board.



### Downloading the Voter Registration Verification Form

- 1 Visit the Voter Portal at <https://okvoterportal.okelections.us/>.

By using the OK Voter Portal, I understand that:

- Residence address changes may only be made if both the old address and new address reside in the same county.
- Rural routes or directions to your home cannot be verified through this system.
- PO Boxes are not allowed as a valid residence address.
- I cannot change my name.

For a new registration, a name change, or to make an address change that crosses a county line, or is a rural route, or directions to your home, please [complete a Voter Registration Application online](#).

You must affirm that both of the following statements are true by checking the box beside each one.

**I swear or affirm that:**

- I am a citizen of the United States and I am a resident of the State of Oklahoma.
- I am 18 years old or older, or I will be 18 on or before the date of the next election.
